Our first snowfall, for some of us, reminds us that the boating season is truly over!

Our 2019 Board is in place following our November meeting. At our meeting a new board was voted in with the exception of the Rear Commodore position which was vacant. However I am pleased to inform membership that immediately following the meeting, members stepped up to address the vacancy. As a result, Sherry Samar stepped up as Treasurer and Vicky Carr as Rear Commodore. We now have a full board in place for 2019. Thank you to Sherry, Vicky and Ralph for joining the Board. And thank you to Mike, Una, Bob, Denise, J and Sherri for continuing to serve on our board.

Our December Board meeting was very productive covering a range of topics. Our planning for 2019 events is underway, beginning with our Change of Watch gala on 23 February. Here are two items I want to follow up on that I brought to your attention at the November membership meeting and in November's Lifeline. The topics that I am referring to are: Consideration of an annual membership fee increase from the current \$75 per year, and kicking off a contest to select a new logo for PWYC.

Membership Fee Increase: The topic of an increase was discussed, with input provided by the board and members in attendance. A motion was approved to defer the decision until our January meeting (12 January @ 10.00 am) pending additional budget analysis for input to the board's decision. While we will revisit this topic at January's meeting, I want to highlight the basis for my belief that a fee increase is warranted, and I welcome your input via email and/or join us at January's meeting.

- **Event Costs:** It is our mission to host a series of great events throughout the year, and in the years since the last increase, inflation has had a significant impact on our event costs and thus our ability to meet this mission.
- IT Services: It has become problematic to maintain a high quality of experience for our website and email services that we greatly rely on to communicate with membership. The challenge is that ongoing support requires a specialized skill set that is not consistently available from membership volunteers year over year. Therefore it is the board's opinion that we need to hire an IT Services provider. This is a new budget line item that cannot be supported with our current revenue projection.



- **Budget Margin:** I believe we need additional budget margin to support events throughout the year. For example, in addition to the budget contribution to the COW, we are required to make advance payments to secure facilities, etc. This requires a reserve of funds in advance of revenue intake from the event.
- **Crazy Eddie Bargain:** Finally, as yacht club membership fees go, PWYC is a "Crazy Eddie" bargain with great events, facilities and fellowship throughout the year.

PWYC Logo Refresh: As I mentioned at our November meeting I'd like to kick off a contest for members to provide their creative input for a new PWYC logo. At our December board meeting I proposed kicking off a contest leading up to presenting the winning design at our COW. The board approved a motion to delay the kickoff of a contest until after the holidays leading up to our 2019 Opening Day. While changes to our burgee requires a revision to our by-laws, subject to a membership vote, the board can proceed with a PWYC logo contest that captures the creative input of our membership of how we should represent the PWYC brand to the greater boating community, through the various means of communications we use such as our website and FaceBook. Look for follow up details, rules and timeline in our next Lifeline following our January board meeting.

Planning for our Annual Change of Watch gala is coming along nicely under the leadership of this year's captain Sherri Connelly. I do need membership's help with two items,

- Steamboat Willy Award Nominations: Presentation of the Steamboat Willy Award is a great PWYC tradition, and is one of the highlights of our COW. So please send me your nominees and their story of a humorous boating incident that occurred in 2018. The nominee criteria for the Steamboat Willie Award is an incident where a temporary lapse of good captainship occurred, but where the only damage is to the captain's pride.
- Slide show: For those who attended our November Captain's Hour, Chili Cookoff and Photo Contest you remember the slide show where we displayed all the 2018 Photo Contest entrants. We thought we would expand this idea to prepare a slide show of member's favorite photos from the 2018 boating season. Please send me your photos to include in our COW slide show!


