

- 3. The Grand Baby of them all.... Our Annual Dock Crawl! 13 May @ 6PM... All hands! There will be a massive party along Sea Ray Boulevard sponsored by all docks. Food and drink sponsored by your Dock Reps and their respective Dock Mates.

Here we are in May and the Spring flowers should be in sight. What a wonderful winter that past us by. I think I saw snow once. I gave the end of March and the beginning of April a chance to come back with a vengeance, but it didn't and now the color of most boats in the marina is yellow due to the pollen. Yep, Island Time is one of them, but she is in for some cosmetic work, a little nip and tuck, and then a well deserved spa day, okay spa days.

As for PWYC cruises, the PWYC Mother's Day cruise, to the DC Wharf, is right around the corner (6-7 May). Planning is underway for 10 boats on the float plan and slip assignments. We always have a great time up there as there are numerous places to go and things to do. It's a few blocks from the National Mall for those who like a little trek and the new location for the International Spy Museum is just a 12 minute walk.

Our next cruise is the PWYC Memorial Day Raft up at Mattawoman on 26-28 May. Mike Manning will be championing this event as he wants to learn the ins and outs of coordinating a raft up. He will have plenty of assistance as he checks off this block in his experience log. This was a suggestion from last year as slips were unavailable and you had to pay for a three day minimum no matter what. Another suggestion was to have an early raft up with experienced captains to provide guidance to those who have never rafted up before. Rafting up can be intimidating especially when asked to drop an anchor or securing lines with other boats. This will benefit the first timers and even the most experienced captains as the unexpected always raises its ugly head.

The PWYC Father's Day cruise to Colonial Beach is planned for the 16-18 June, some have already booked their slips. Please see the flyer in this Life Line. This is a Co-Sponsored event with Prince William Marina and PWYC. Details are forth coming on this cruise.

If you would like to help out on any of the cruises contact the cruise champion or any one on the board and they will gladly take your offer. This is a good way to learn the ins and outs of coordinating a group trip for any occasion by someone who has some experience in contacting marinas, building a float plan, and guiding a flotilla to any given location.

Safety inspections by the Coast Guard Auxiliary have begun and Island Time passed with flying colors. I hope everyone that were getting their vessel inspected on the 8th and 9th didn't have any issues either. I didn't see any walks of shame so maybe that was a good thing. You know that walk, the captain that went to turn on his anchor light and both bulbs were out, or looked at his flares and the expiration date was the week prior to his inspection.

The next dates for vessel safety inspections are 15 April and 13 May. For those that are still needing their boat inspected please pre-check all items on the inspection sheet. There is a check list on the PWYC website to make sure everything on your boat is in good working order according to Coast Guard guidelines.

Below is the list of upcoming trips and with the person championing them. I still need a Champion for two of the cruises. Again, if you would just like to help out on any of the cruise or PWYC events for that matter, please contact the Champion for that cruise or you can contact me at rearcommodore@pwyc.org and I will

assist getting you in touch with the right person. I am working with PWM for the Father's Day cruise. Coordination is underway. Please see the attached flyer. If anyone would like to help coordinate, please contact me as there are a lot of moving parts to this cruise such as activities during the day and potential cook out on one of the evenings.

2023 Progressive Dinner on the Docks – June 24, 2023

Ahoy PWYC boaters! We are excited to invite you to participate in this year's progressive dinner party. It is a super, one-of-a-kind event to meet fellow boaters, show off your "home away from home" (you know--your boat, your seaworthy chateau, your Potomac Palace!), see other member's classy crafts (boats!), and enjoy great food, fine drinks, and amazing friends!

This year's PWYC Progressive Dinner on the Docks will take place on Saturday, June 24th, 2023 from 5:00 pm to 10:00 pm. We are hopeful that you will choose to be a part of this unforgettable fun-filled

event. Philip and Heidi Schoepflin will be coordinating the event and can be reached at: philip.schoepflin@gmail.com.

Here's how it works:

- -There will be a total of four courses served throughout the evening. They are:
- 1) First Course- Appetizers and cocktails will kick off the evening for everyone and will be served at the deck near the Bath House located near C-Dock. This will be a chance to meet and greet all participants and share sea stories as we begin the event.
- 2) Second Course- Soup/salad course with a beverage will be served by your hosts on the first boat you will visit.
- 3) Third Course- Main dinner entrée with a beverage will be served by your hosts on the second boat you will visit.
- 4) Fourth Course is our dessert and coffeehouse finale to the event which will be hosted by the Boatel in the upstairs community room of the Blue Bath House. This will bring everyone back together to finish out the evening with continued sea tales among shipmates, sweet tooth enjoyment, beverages and more great conversation.
- -Each boat serving either a second or third course will host between 4 and 8 guests at their boat (based on group size offered by boat Captain). It's totally up to you what to serve...though you will want to make it something you can easily have ready within a few minutes of arriving to your boat from the previous course. (Hosts can leave the previous course 10 min early to prepare for the arrival of their guests.)
- -At each of your stops you will be with a new group of fellow boaters.
- -All participants, once they have RSVP'd to Philip and Heidi at: philip.schoepflin@gmail.com, will be emailed a confirmation of their attendance at the event and the course they have decided to cover.

-As mentioned previously ALL participants will meet at the deck of the Bath House near C-Dock at 5:00 pm for the First Course. It is during the First Course that you will receive an envelope containing the name and location of the boat you will report aboard for the Second Course.

This envelope will be opened upon the sounding of the boat horn signaling the end of the First Course and you will begin making your way to the Second Course host boat found within your envelope.

- -Upon completion of the Second Course, the boat horn will sound and the host boat's Captain will give you an envelope with the name and location of the boat you will enjoy your Third Course aboard. This envelope will be opened upon receipt and you will begin making your way to the Third Course host boat found within your envelope. After the Third Course, the final boat horn will sound, notifying everyone to make their way to the community room of the blue bath house for the Fourth Course of dessert and coffee (and perhaps more cocktails?).
- We anticipate starting at 5:00 pm, with about 50-60 minutes for each of the first three courses and about two hours for the fourth course.







Another Boating Season Starts—Some Things To Think About

As the pollen fills the air and our lungs, it can only mean one thing...boating season is upon us. Everyone is anxious to get dewinterized or maybe those last few pre-season projects completed. But, in our haste, it's important that we slow down and think about how to actually prepare for a safe season.

When you mention "Safety" to most people, eye begin to roll. A chorus of "yeah, yeah, whatever" echoes across marinas everywhere. But, the truth is, boating is inherently dangerous and the time to think about its dangers and how to do some risk reduction, is not in the middle of the emergency.

- In calendar year 2021 the USCG counted 4,439 accidents that involved 658 deaths. Most incidents occurred during benign weather conditions: calm waters, no or light wind, and good visibility.
- Where cause of death was known, 81% of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 83% were not wearing a life jacket. It is the responsibility of each boat captain to follow the rules of Virginia, Maryland, and the District of Columba regarding the wearing of personal flotation devices for children 13 years and under.
- It critical to wear a life jacket when underway as it may be difficult to don one in an emergency. The life jackets should be serviceable, properly sized, correctly fastened, and suitable for the activity."
- Alcohol continued to be the leading known contributing factor in fatal boating accidents in 2021, accounting for 86 deaths, or 16 percent of total fatalities.
- Operator inattention, operator inexperience, improper lookout, machinery failure and excessive speed ranked as the top five primary contributing factors in accidents.
- Where boating instruction was known, 75 percent of deaths occurred on vessels where the operator had not received boating safety instruction.
- The most common vessel types involved in reported accidents were open motorboats, personal watercraft, and cabin motorboats.
- Where vessel type was known, the vessel types with the highest percentage of deaths were open motorboats (44 percent), kayaks (15 percent), and pontoons (10 percent). This is the second time that pontoon vessels ranked in the top three.

B. When Entering & Leaving The Marina Fairways

- The purpose is to make the Occoquan River as safe as possible for everyone who uses it. It is not to point a finger but to accept the responsibilities imposed on each of us.
- The following have been determined to be vessels by the Coast Guard, the lead agency in determining what is and is not a vessel.

- Human-powered craft such as kayaks and stand-up paddleboards.
- > A person drifting down the river on a tree trunk.
- > Someone floating down the river on an inner tube.
- > Any motor-powered craft.
- Simply put in Rule 2 of the published Rules of Navigation (COLREGS), every vessel has equal rights to use the Occoquan according to the rules of the road. No vessel, motor driven, wind-driven, or human-power-driven is automatically given the right of way over any other vessel.
- Inland General Rule 2 Responsibility: Nothing in the Rules exonerate any vessel, or the owner, master, or crew from the consequences of any neglect to comply with these Rules or of the neglect of any precaution which may be required by the ordinary practice of seamen, or by the special circumstances of the case. In construing and complying with these Rules due regard shall be had to all dangers of navigation and collision and to any special circumstances, including the limitations of the vessels involved, which may make a departure from these Rules necessary to avoid immediate danger.
- It is not wise to read the Rules of the Road as if each were in a vacuum. Each encounter may bring its own set of circumstances.

C. The New Virginia Move Over/Slow Down Law

- By all reports, the Virginia Move Over/Slow Down Law will be enforced.
- As of this writing Tow BoatUS and SeaTow are included under the Virginia Move Over/Slow Down Law
- 4VAC15-390-85. Operators to give right-of-way and reduce speed.
 - "Every motorboat, when approaching or passing within 200 feet of any law-enforcement vessel or emergency services vessel that is displaying flashing blue or red lights shall slow to no wake speed so that the effect of the wake does not disturb the activities of law-enforcement personnel or emergency services personnel. Where the operator of a motorboat fails to comply with the provisions of this section and such failure endangers the life or limb of any person or endangers or damages vessels, the operator shall be guilty of a Class 3 misdemeanor. Upon conviction, the operator shall additionally be required to complete and pass a National Association of State Boating Law Administrators approved safe boating course as required in § 29.1-746 of the Code of Virginia."
- Everyone is on their own while using the narrow Occoquan Channel or the no wake zone when coming upon a covered vessel.

The following information comes from the City of Annapolis website:

Practice Day: May 23rd, 2023

Around 10:30 am: The restricted zone in the Severn River is closed to all unauthorized traffic.

Around 2:00 pm: Practice air show begins.

Around 4:00 pm: Once the all-clear is given, the Severn River will be open to all vessel traffic.

Show Day: May 24th, 2023

Around 1:30 pm: The restricted zone in the Severn River is closed to all unauthorized traffic.


Around 2:00 pm: Air show begins.

Around 4:00 pm: Once the all-clear is given, the Severn River will be open to all vessel traffic.

There will be a temporary channel in place marked with red and green buoys. This channel MUST be kept clear of anchored boats throughout the duration of the shows. You will be moved if you are anchored in this zone.

See the map below that will show the temporary zones that will be in place for the few days during the event.

Anchoring is only allowed outside of these red restricted zones. The best places to anchor are off of Greenbury Point by Carr Creek, or on the other side of the flight box closer to the Rt. 50 Bridge.
