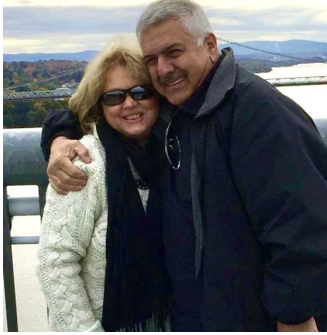

The Boating Season Is In Full Swing

We cannot forget about the statistics. As always, everyone is on their own out there. It is up to each of us to decide whether or not we want to tempt the safety gods.

Here is the Executive Summary from the latest US Coast Guard Recreational Boating Statistics. The complete drill down link is attached at the end.

Can we reach any conclusions based on the information presented and the type of vessel we use?

- Where cause of death was known, 79% of fatal boating accident victims drowned. Of those drowning victims with reported life jacket usage, 86% were not wearing a life jacket.
- Where length was known, eight out of every ten boaters who drowned were using vessels less than 21 feet in length.
- Alcohol use is the leading known contributing factor in fatal boating accidents; where the primary cause was known, it was listed as the leading factor in 23% of deaths.
- Operator inattention, improper lookout, operator inexperience, excessive speed, and alcohol use rank as the top five primary contributing factors in accidents.
- Where instruction was known, 70% of deaths occurred on boats where the operator did not receive boating safety instruction. Only 20% percent of deaths occurred on vessels where the operator had received a nationally-approved boating safety education certificate.
- There were 171 accidents in which at least one person was struck by a propeller. Collectively, these accidents resulted in 35 deaths and 155 injuries.
- Where data was known, the most common vessel types involved in reported accidents were open motorboats (45%), personal watercraft (19%), and cabin motorboats (16%). Where data was known, the vessel types with the highest percentage of deaths were open motorboats (48%), kayaks (14%), and personal watercraft (8%).

Another Year, Another Hurricane Season

June 1 was the official opening of the 2021 Atlantic hurricane season. However, The season was off to an early start. Ana already had formed in the waters 200 miles northeast of Bermuda at 5 a.m. EDT on May 21.

Ana's formation came more than a week before the official start of the Atlantic hurricane season. This marks the seventh consecutive year that a pre-season named storm had formed before the official start of the Atlantic hurricane season.

The previous record was four consecutive years, which was set 1951-1954. Although the National Hurricane Center has not changed the June 1 start date of the Atlantic hurricane season, it did move the launch date of its daily Tropical Weather Outlooks to May 15 starting this year.

BoatUS provides a ton of advice on how to prepare a vessel to withstand a hurricane. They are aces in providing advice to offering worksheets, to determining how secure a marina is to withstand a hurricane.

Preparing our vessel for a hurricane is one thing. Preparing ourselves is another. Vincent Pica Commodore, USCG, believes that if any group of people should know how to prepare for a hurricane, it should be people serving in the Coast Guard.

He offers an extensive check list of the things he believes his people, and by extension the rest of us, should stock up on if we want to be adequately prepared if/when a hurricane approaches. He does say that everyone may not or cannot do all the things he suggests – but it will make everyone ask themselves “Should I?”

The Commodore divides his detailed check list into six basic categories; water, food, first aid supplies, clothing and bedding, tools and emergency supplies, and special items. He stresses that the items one would most likely need during an evacuation should be kept in an easy-to-carry container.

He includes an extensive list of items under each category. Open the link below for a full listing if those things he thinks important for his Coast Guard people to have on hand should a hurricane approach.

VHF Radio Checks

The Coast Guard has issued a reminder to inform mariners of the proper procedure for performing a VHF radio check. **VHF channel 16 is not for the purpose of radio checks. They suggest that VHF Channel 9 be used. This Channel has been designated by the FCC as a boater’s calling Channel.** The full link is at the end.

For several years, Sea Tow operated an Automated Radio Check System, which was available on VHF channels 24 to 28 for the benefit of mariners in over 130 locations. This service was discontinued on October 2nd, 2020.

How to test a VHF Radio using Rescue 21: The U.S. Coast Guard continues to offer an automated Digital Selective Calling (DSC) Test Call capability from each of its Rescue 21 coastal stations. All fixed mount marine radios certified by the Federal Communications Commission since 1999 are required to have a DSC capability. All such radios sold since 2011 must also have a DSC test call capability.

Marine radios transmitting and successfully receiving a response from a DSC test call can be expected to operate acceptably in the voice mode as well.

To perform a DSC Test Call, enter the U.S. Coast Guard’s coast station group identity “003669999” into the radio’s DSC memory. Once entered and stored, a DSC test call can be made by executing the following three steps:

Select “Test Call” from the radio’s DSC menu,
Select the USCG number entered into memory, and
Transmit the call.

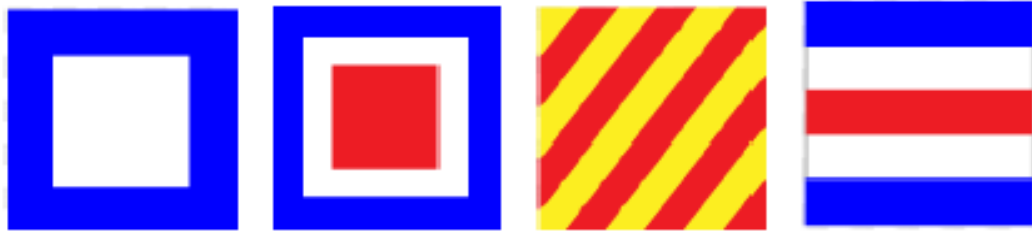

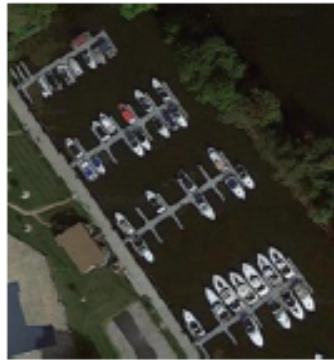

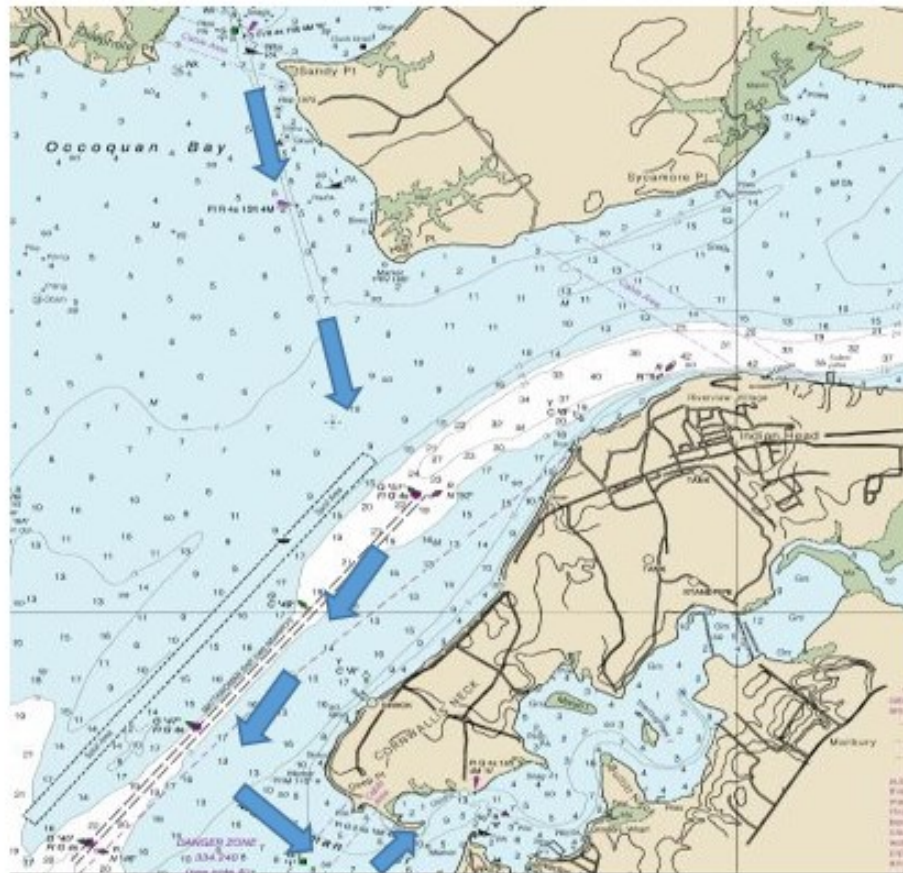
